

Dear Parent,

Offline classes for IX & XI are scheduled from October 11-30, 2021. Periodic Test- II for class IX will be held during this time. Classes will continue after the exam. The schedule for classes and the periodic test is uploaded on the school website and also shared in class groups. You are requested to fill the given undertaking and send it to the class teacher on Whatsapp on or before October 7, 2021. The hard copy of the undertaking should be submitted at the school gate on the first day of the school. Students of Class XI who have not submitted the consent earlier should submit it to the class teacher on the first day of the school.

The school will follow the Standard Operating Procedures issued by CBSE and the DOE, Govt of Delhi:

1. Thermal scanners and hand sanitizers at the entry and exit gates.
2. Sanitizer dispensers on all floors and soap dispensers near the washrooms.
3. Physical distancing will be ensured inside the school premises.
4. Appropriate back-up stocks of personal protection items like face masks and handsanitizers.
5. Medical Room equipped with Oximeter to check oxygen saturation levels. There will be a full-time nurse as well.
6. Entry of visitors will be restricted.
7. Seating arrangements with a distance of 6 feet.
8. Cleaning and regular disinfection of labs and classrooms and frequently touched surfaces and hand washing areas and washrooms at regular intervals.

We expect students to follow these guidelines in school:

1. To maintain physical distancing of 6 feet.
2. Coming to school (in full school uniform) with face masks covering the nose, mouth and chin at all times.
3. Using sanitizer whenever required.
4. Self monitoring of health and reporting any illness at the earliest.
5. No sharing of books, stationery items, lunch (food) and water bottles.
6. Students are not allowed to carry mobile phones, cameras, I-pods or any other electronic gadgets to school.
7. Students should go straight to the classrooms assigned to them. Crowding is strictly prohibited inside and outside the school.
8. Students should enter the school 10 minutes prior to the beginning of the class.
Students without the undertaking form will not be permitted to enter the school.

Note: There will be no online classes for students on the days that they come to school.
